# PRIVACY POLICY

This privacy policy applies between you, the User of this Website, and CMB Dental Laboratory Ltd, the owner and provider of this Website. ## Definitions and interpretation

- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

- 3. This privacy policy applies only to the actions of CMB Dental Laboratory Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

## Data that is given to us by you

  - e. relevant authorities to facilitate the detection of neglect, harm, self harm, abuse or disease detection;

in each case, in accordance with this privacy policy.

#### Keeping Data secure

- 12. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.
- 13. We are certified to Information Commissioners Office. This family of standards helps us manage your Data and keep it secure.

#### Data retention
